INTRODUCTION

Hong Kong Women's Ice Hockey League (**HKWIHL**) 2018 - 2019 will begin its sixth hockey season soon (August 2018 – April 2019). This league caters to all female players in Hong Kong and sets the ground work for consistent player development. In addition to the games there will be monthly practices which are structured and executed by coaches. HKWIHL aims at being a training ground and part of a feeder system for the Hong Kong Women's National Ice Hockey Team (**HKWNIHT**) which is now eligible for IIHF World Championship competition.

HKWIHL is organized by an experienced team which includes, Women's Ice Hockey Organization (WIHO) and Hong Kong Amateur Hockey Club (HKAHC) and sanctioned by Hong Kong Ice Hockey Association (HKIHA).
